Our work over the years would not have been possible without the invaluable insight and guidance of our Advisory Council. We would like to express our sincere gratitude to Mr S Dhanabalan, who stepped down in 2018 as Chairman of the Advisory Council. 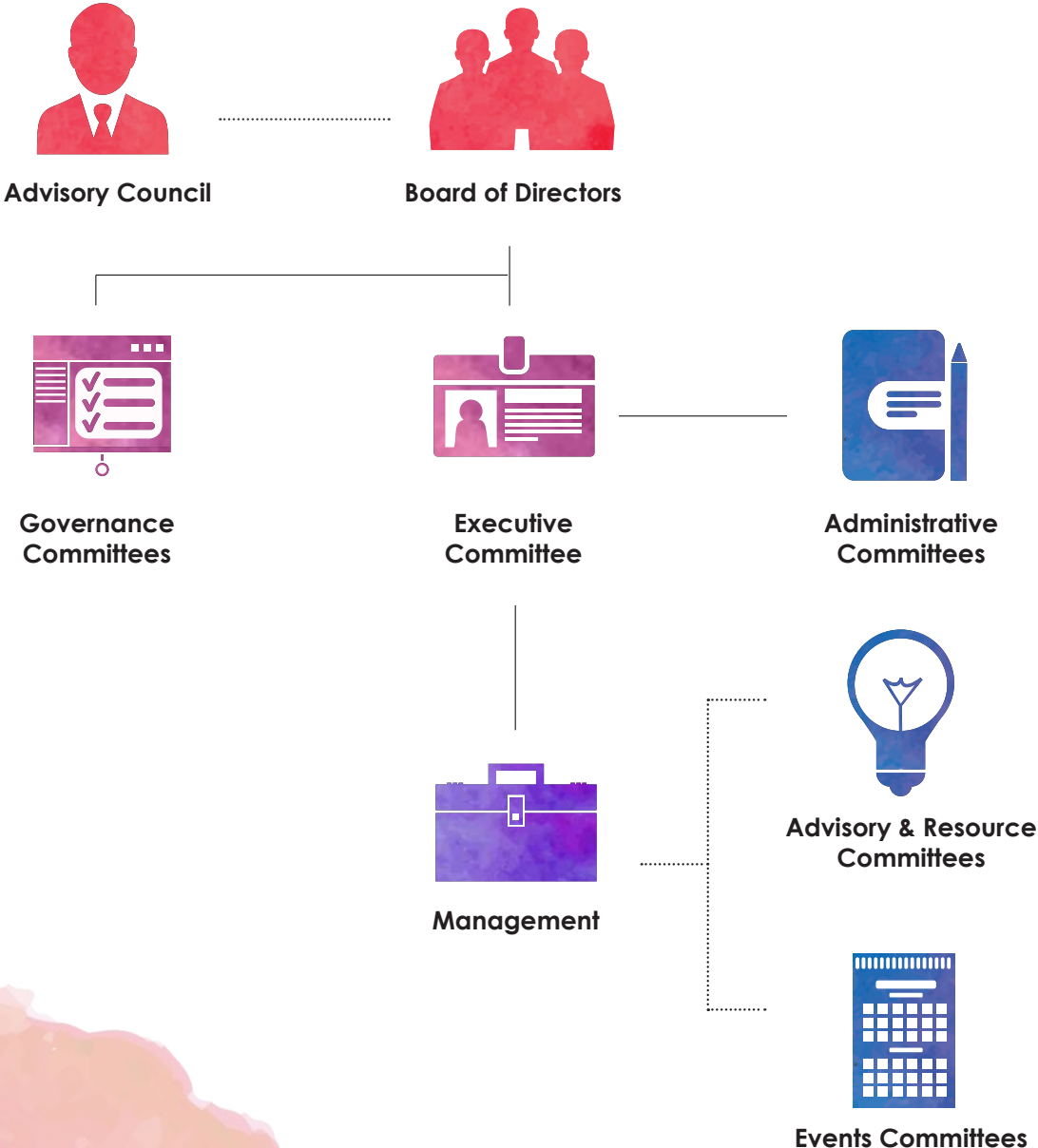

YMCA-TAN CHIN TUAN COMMUNITY SERVICE PROGRAMMES

Stepping Out Of His Comfort Zone

After participating in the Y Camp Challenge, one of 13 programmes under the YMCA-Tan Chin Tuan Community Service Programmes, Aaron wanted to give back. He volunteered to emcee for the first time at YMCA's annual Giving Gala despite his parents' concerns over his schedule as he was working two jobs. Despite that, he insisted on taking up the opportunity, and earned their approval and encouragement through his determination.

YMCA-Tan Chin Tuan Community Service Programmes are volunteer-driven programmes that strengthen clients, including the physically and mentally challenged, under-privileged and abused children, the hearing-impaired, poor, and the elderly.

HIGHLIGHTS OF COMMUNITY SERVICE PROGRAMMES



Y Camp Challenge

Y Camp Challenge is a quarterly outdoor adventure camp for the intellectually or physically challenged. It provides these clients with opportunities for social integration with their volunteers. By overcoming their perceived limitations in various activities such as high rope elements and camp craft, their confidence grows, building self-worth and serving as an inspiration for their loved ones.



Y Arts Challenge

Y Arts Challenge engages underprivileged, intellectually challenged or hearing impaired children and youths through performing and visual arts. It gives them a platform for creative self-expression and develops their hidden talents. To build their confidence, various platforms are provided for these clients to showcase their talents and crafts, including dance performances at events and art exhibitions.



Y Outing

Y Outing engages clients monthly through a range of indoor and outdoor activities, including going on excursions to places of interest. It provides the opportunity for them to mingle with volunteers and each other during these outings, developing their interpersonal skills and self-esteem. Through a myriad of activities, they also gain life skills such as travelling, safety preparations, appropriate behaviours in public places and being responsible for their own belongings.

Y Food of Love

Y Food of Love brings cheer to the less privileged by equipping volunteers with baking skills, which they use to prepare handmade delicacies for clients in their homes or at activity centres. During these visits, volunteers also befriend them and entertain them through games. They also celebrate festivals such as Chinese New Year and Christmas with them, distributing festive goodies at the same time.



Y Makan Fellowship

Y Makan Fellowship treats the elderly to sumptuous meals once a month, with youth volunteers interacting with them over songs, games and other fun activities. This programme promotes intergenerational bonding and trains volunteers in communication skills to better serve elderly populations.



YMCA Spring Clean

Y Spring Clean brings volunteers to create clean and safe living environments for the elderly. Many of these elderly are physically or sensory-challenged, which makes poorly maintained homes a severe health and safety hazard. Apart from physiological benefits for the elderly, they also get to enjoy the company of volunteers who visit regularly through this programme and form friendships with them.

INTERNATIONAL SERVICE PROGRAMMES

New Lands; New Perspectives: Volunteering as a Journey

Under the YMCA Financial Assistance and Capability for Employment Scheme (Y FACES), he receives financial aid for the purchase of daily necessities and health supplements. He is appreciative of the assistance and wishes to equip himself further so that he can help others in need.

YMCA FACES extends short-term emergency financial aid to needy families and provides meaningful work training opportunities for individuals with special needs. It works closely with various Family Service Centres and partnering organisations to identify people in urgent need or families in difficult transition periods to provide aid.

From Isolation to Excellence & Employability

Leng Leng experienced great difficulty coping with English as a foreign language when she first came to Singapore in 2017. After being referred to the VaSSP, she completed the hairdressing course mentored by the Kimage Hairdressing School. The Kimage Hairdressing School is a partnering school that sponsors students through the VaSSP Hairdressing course, which is one of the nine available courses. She excelled so outstandingly that they offered her a job and decided to sponsor her further education in hairdressing through Nitec and Higher Nitec.

Project Bridge seeks to reintegrate out-of-school youths and youths-at-risk into society by strengthening their skill sets and employability. Project Bridge is primarily implemented through the Vocational and Soft Skills Programme (VaSSP), Enhanced Step-Up Programme and Drop-In-Youth Programme.

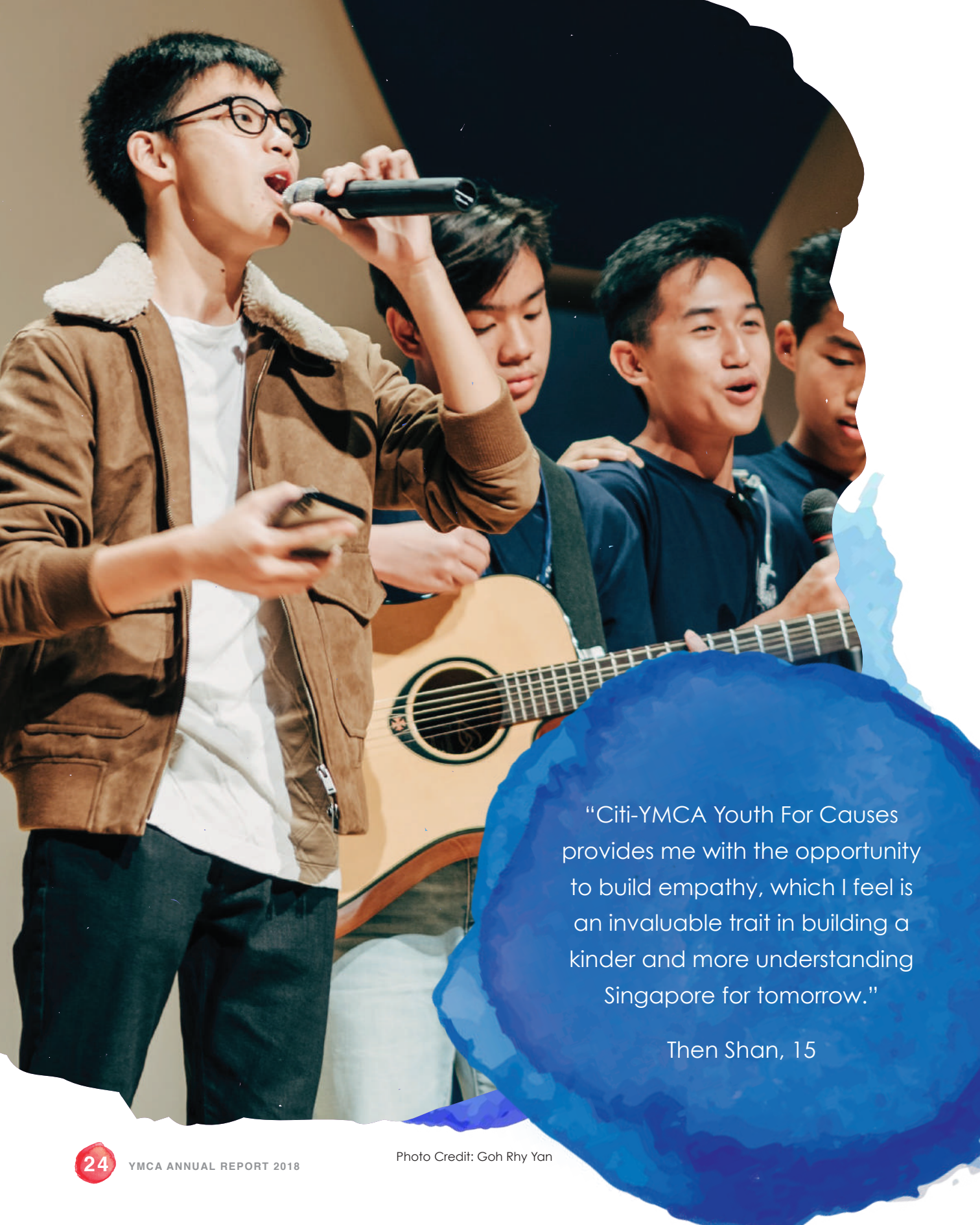

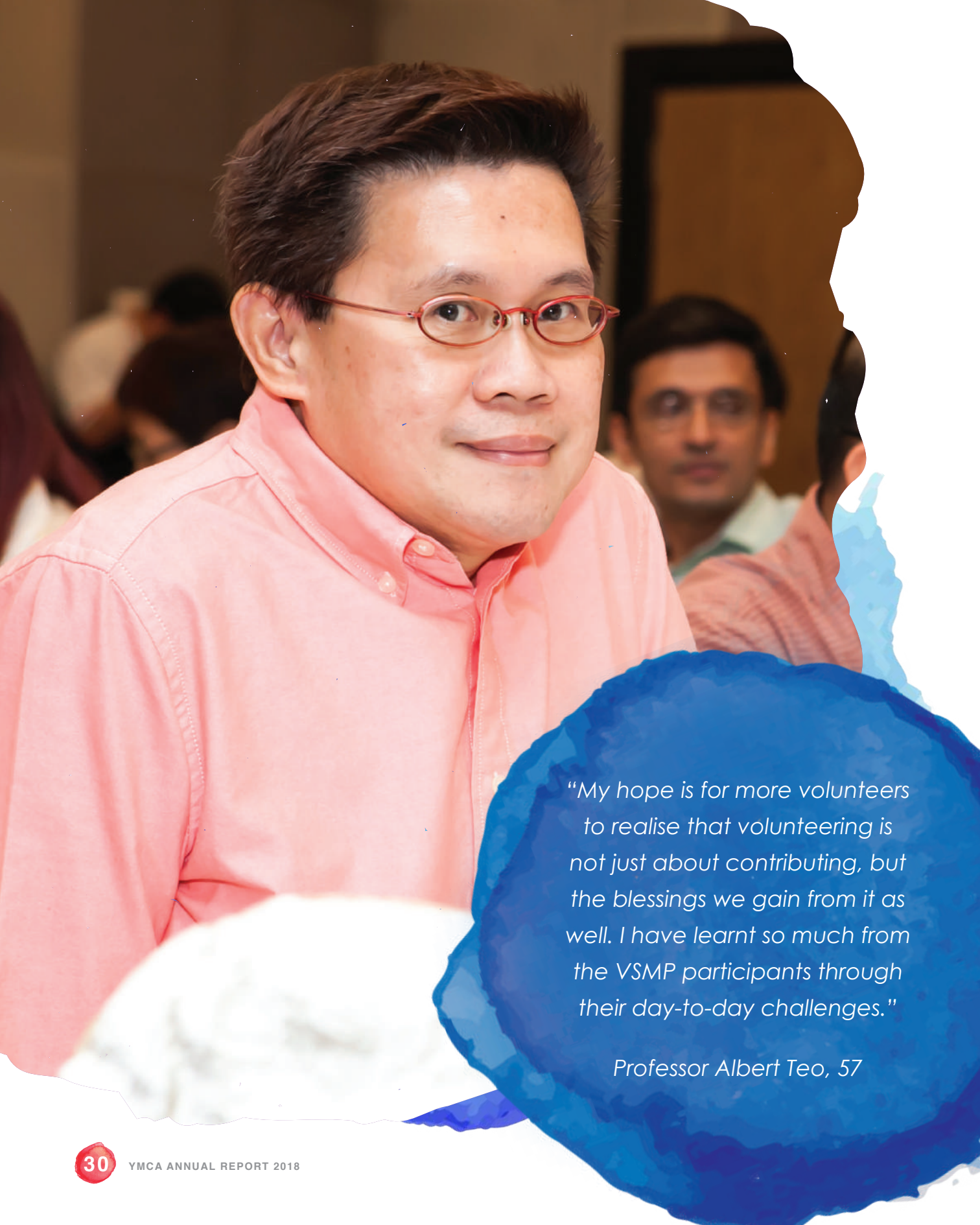



POLICIES

YMCA of Singapore is governed by the Constitution of the Association and has complied with the Code of Governance for Charities and Institutions of Public Character.

BOARD GOVERNANCE

Office Bearers

At the first meeting of the Board of Directors (BOD) held after the Annual General Meeting, a President, two Vice Presidents, an Honorary Secretary, and an Honorary Treasurer of the Association are elected from among the members of the BOD for a period of one year or until their successors are elected. No person is elected as the Honorary Treasurer or otherwise hold the office of Honorary Treasurer for more than 4 consecutive terms and such person shall only be eligible for re-election as Honorary Treasurer after a lapse of at least 1 year.

Executive Committee

The Executive Committee ("ExCo") comprises the President, two Vice Presidents, an Honorary Secretary, and an Honorary Treasurer and at least one other Director. It has the executive powers to administer the affairs of the Association in accordance with its Constitution, Rules and Regulations and the Board's policy and provides guidance and oversight to the Management on the operations of the Association. These include the setting of policies on operational matters and approval of expenditures within the financial limits provided for in the Chart of Authority ("COA") in the normal course of business. ExCo keeps the BOD fully informed on the affairs of the Association and where appropriate, refer certain matters to the BOD for approval.

HUMAN RESOURCE MANAGEMENT

There are systems for regular supervision, appraisal and professional development of staff and a system to address grievances and resolve conflicts. The HR department is advised by a Staff Committee commissioned by the Board. The Committee reviews and advises on all HR policies relating to staff compensation, benefits and strategies to attract, retain and motivate staff, on the receipt of recommendations from the General Secretary & CEO. The Committee also advises on talent identification and development programmes for staff and succession planning of senior management staff.

Whistle Blowing Policy

The YMCA Whistle Blowing policy aims to provide an avenue for employees and external parties to raise concerns and offer reassurance that they will be protected from victimisation for whistle blowing in good faith.

This policy covers issues where the following may be suspected:

1. Corruption;
2. Acts of fraud;
3. Theft and/misuse of the Association's properties, assets or resources; or
4. Breach of laws

No staff is involved in setting his or her own remuneration. Staff remuneration is subject to remuneration guidelines approved by the BOD.

The Association discloses in its annual report the annual remuneration of its three highest paid staff who each receives remuneration exceeding \$100,000, in bands of \$100,000, or the fact that none of its top three highest paid staff receives more than \$100,000.

FINANCIAL MANAGEMENT AND CONTROLS

The BOD ensures that documented procedures are in place for financial matters in key areas. The BOD also ensures reviews and enhances monitoring on controls, processes, key programmes and events.

The BOD reviews and approves an annual budget for the Association's plans and regularly monitors financial performance.

The financial statements of the Association are drawn up in accordance with the Statement of Financial Reporting Standards in Singapore ("FRS").

The Association discloses its reserves policy in the annual report.

The Association does not make any loans.

Reserves Policy

YMCA targets for three years of operating reserves with a minimum of one year from donations and surpluses generated through our social enterprises. These reserves will ensure that our ability to serve the community is not subjected to the vagaries of the economy. As at the end of 2018, our ratio of reserves to annual operating expenditure stands at 0.7 years.

The restricted funds and their purposes are as follows:

I. Building Asset Capitalisation Reserve – to match amounts on capital projects undertaken with past donations designated for that purpose. This fund will be amortised in line with the depreciation policy of the underlying capital projects

II. Disaster Relief Fund – to support the volunteer relief and rehabilitation works undertaken by the Association in Sri Lanka, following the 2004 Indian Ocean Earthquake & Tsunami

III. YMCA-Seet Hiong Kiat & Kuah Siew Eng Education Funds – to fund tertiary education for overseas needy students

IV. ISP Project Fund – set up for the International Service Programmes (ISP) and it is to be used for future ISP projects

V. Project Bridge Fund – supports Project Bridge programmes which aim to provide personal development and counselling for early school-leavers and youth-at-risk

VI. Rebuilding Community @ Dujiangyan Fund – set up for the purpose of supporting YMCA's rebuilding programmes in Sichuan, China

YMCA has also other designated and unrestricted funds set aside for various community programmes listed in the Notes to the Financial Statements. YMCA has also designated a percentage of our annual surpluses from our social enterprises for large scale asset renewal as our capital replacement fund.

Investment Committee

The Investment Committee is governed by the Investment Charter and the Investment Policy which are constantly reviewed to allow for flexibility according to the market environment. It is appointed by the BOD to exercise prudence and good stewardship in relation to the investment of the Association's funds to look into generating higher returns in the long run with a reasonable amount of risk.

The Association appointed a professional asset manager to invest and manage the surplus from the general funds. The Asset Manager has been given full discretionary mandate subject to the Association's Investment Policy, and reports the investment holdings and performance to the Investment Committee on a regular basis.

DISCLOSURE AND TRANSPARENCY

There is a Conflict of Interest policy endorsed by the Board. Annually, the Board Directors and Management Staff make declarations of actual or potential conflicts of interest to the Board.

It is compulsory for all Board members to make annual declaration of interests, to be signed and acknowledged by the President of the Association and presented to the Board.

At committee meetings, the General Secretary & CEO of the Association will announce potential conflict of interest and Board members who are faced with a conflict situation are excluded from decision making processes relating to the matter.

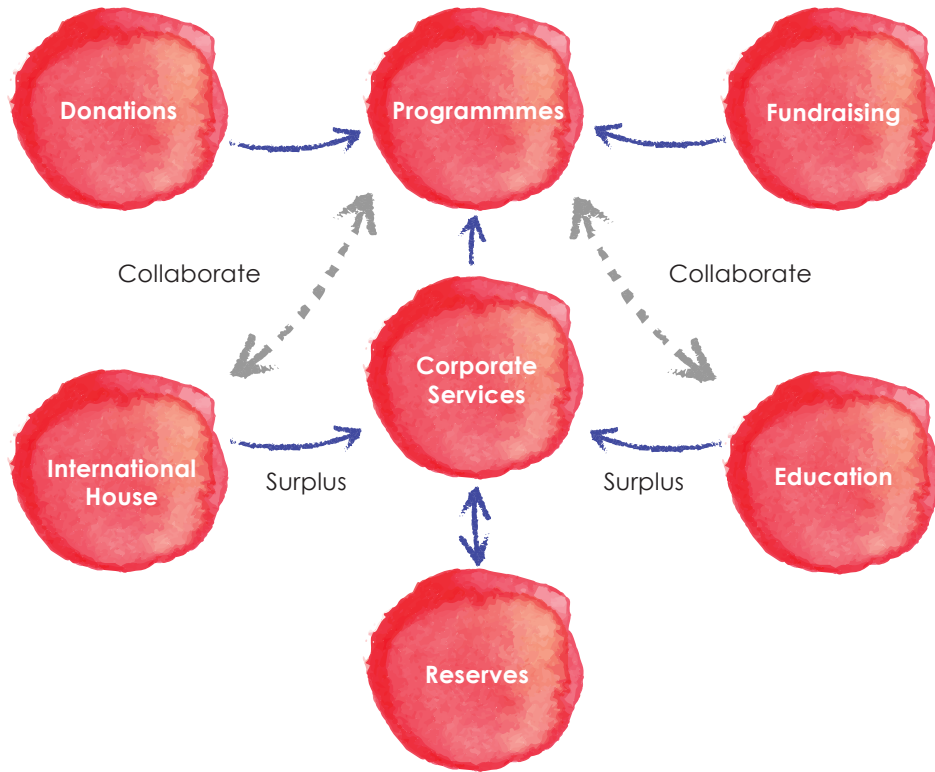
FUNDRAISING PRACTICES

The Association has established guidelines on fundraising. These guidelines are based on the best practices set out by the National Council of Social Service and the Charity Council.

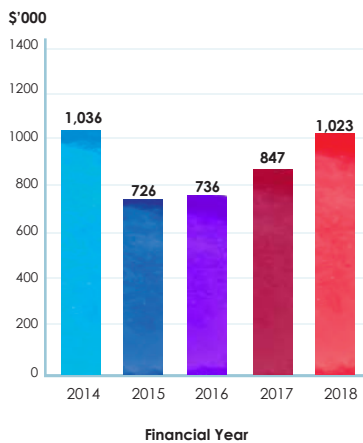
The committee for each fundraising event consists of volunteers and is supported by staff. The donors are informed of our objectives and targets.

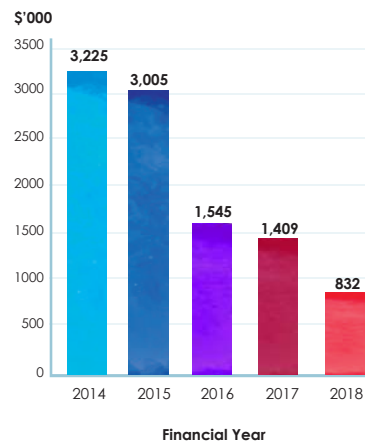
FINANCIAL STRATEGY
